# **General Conference Information**

Conference Registration Fees - All persons attending the NCFR Conference, including program presenters, must register and pay the registration fee. Everyone must stop at the registration desk located in the 8th floor lobby of the Westin Peachtree Plaza Hotel upon arrival (including all who have pre-registered). Packets and name tags will be given at that time. Check the "Ongoing Events" Section of this program for a listing of registration hours.

The basic registration fee includes admission to all plenary sessions, Section sessions, poster sessions, master lectures, focus group sessions, special sessions, Meet the Authors session, entrance to exhibits, and receptions. No advance sign-up is necessary to attend these events. Advance sign-up and fees are necessary for Carousel Seminars (Round Tables), some Special Events, and Pre- and Post-Conference Workshops. Check the registration form found in the center of this program.

Name Tags - Name tags must be worn at all times throughout the Conference. Persons wearing yellow name badges are first-time attendees at an NCFR Conference. Board members, local arrangements committee members, and program committee members will be wearing colored ribbons on their badges. These people will be glad to answer questions or provide assistance.

Hotel Accomodations - The Westin Peachtree Plaza Hotel is the headquarters hotel for NCFR. Rates are \$76 for a single room; \$88 for a room for two. The hotel reservation card is located in the center section of this program. If you prefer to call, phone the hotel at 404-659-1400. Be sure to identify yourself as an NCFR Conference attendee to receive the discounted rates. Conference rates are valid November 11-24. Make your reservations early. The cut-off date is October 24. After that date NCFR's block will be released and rooms are open only as space is available.

- Airfare Discounts NCFR has contracted with Stratton Travel and Delta Airlines, the official carrier for the 1987 Conference. Delta is providing Conference attendees and their families discounted fares of either 5% off the lowest applicable fare available at the time of booking if restrictions can be met; OR 40% below coach class fare if restrictions cannot be met for the lower fare. Canadian members will receive a 35% below coach fare discount. This service is available only through Stratton Travel. If you cannot use Delta as a carrier for your travel, Stratton will find you the lowest applicable fares on other airlines. For further details see the advertisement on page 27 of this program.
- Family Resources Database (FRD) Online Training Workshop and Searching - Learn how to search the Family Resources Database on-line with an easy-to-use menu-drive information system on Sunday afternoon. Searches will be demonstrated in the exhibits area at the NCFR Booth Monday - Thursday. Specific times will be listed in registration packets. A terminal will be available for these sessions.
- Audio Tape Service Wilbur Hutchinson, Custom Audio Tapes, Bridgeport, IL, will again be taping major sessions (plenaries, master lectures, Section meetings and some pre- and postconference workshops). Tapes are available for sale immediately after each session and throughout the conference at a very reasonable cost. Look for the display in the registration area. Tapes are professional quality and fully guaranteed.
- Message Centers Bulletin boards are located in the registration area - 8thFfloor Lobby - for exchanging messages. Note pads are available at the registration booths. Notes should be placed on the bulletin boards in alphabetic order by last name initial. There will be a board in the press room so the media may contact conference speakers. Speakers should regularly check that board for messages. The employment service also has bulletin boards for the convenience of prospective employers/employees who wish to meet during the Conference.

Emergencies - The Local Information Desk/Hospitality Room (Grady Room) has a list of physicians, dentists, drug stores, etc. If an emergency arises during the Conference either call the hotel operator or have Cindy Winter, Conference Coordinator, paged. Do not attempt to dial 911 yourself. Either the hotel or Cindy will contact the proper authorities.

Child Care - The Friend of the Family Child Care Service will be available Sunday - Wednesday, 8:00 a.m. - 5:00 p.m., and Thursday, 8:00 a.m. -12:00 p.m., at a cost of \$4 per hour per child. Parents are responsible for feeding their children between 12:15 - 1:15 p.m. daily. The Child Care Service is located in Tower Room 8 of the Westin Peachtree Plaza Hotel. Check the appropriate space on the Conference Registration Form if you wish to use this sevice.

Local Tours/Events - Guidelines-Atlanta has set up some tours. A list appears on page 25 of the Conference Program. If you wish to sign up for these events, fill out the form which is enclosed with this program and mail directly to Guidelines-Atlanta, P.O. Box 52503, Atlanta, GA, 30355.

Continuing Education Units - Many of the major sessions may be counted as Continuing Education Unit credits for other family organizations. If you wish to receive a certificate, contact the cashier in the registration area and pick up your materials. An evaluation form must be filled out and returned immediately folowing the Conference. A \$5.00 processing fee will be charged.

Meet the Authors - Tuesday evening, from 4:30 to 5:30, there will be several authors present who have recently published books. If you are an author who wishes to participate, contact Cindy Winter, Conference Coordinator. Authors will be seated in an area of the Exhibits and attendees are welcome to discuss these books with the specific authors. Come and join your friends and colleagues and visit the other exhibits.

#### Types of Sessions Featured at

**NCFR** - The NCFR Conference offers a variety of session types throughout the week. A brief description follows:

**Plenary Sessions:** General sessions which may be attended by all registrants. Speakers explore various aspects of the Conference theme. No other sessions are scheduled during plenaries.

Section Meetings: Concurrent sessions which are sponsored by NCFR's Sections. Registrants may attend any of the Section meetings during the specified times. It is necessary to choose one session each time. No pre-registration is necessary. Section membership is not a prerequisite for attendance at these sessions.

Master Lectures: General sessions during which time an expert on a given topic presents a lecture.

**Poster Sessions:** A series of display presentations that allow face-to-face conversation between authors and viewers. Posters are set up near the Exhibits at four different times: Sunday, 1:00 - 2:45 p.m.; Tuesday, 12:15 - 1:15 p.m.; Wednesday, 12:00 - 1:15 p.m.; Thursday, 7:30 - 8:30 a.m. Authors of the posters will be present during these hours. The posters will remain in the exhibits area for an additional hour and a half after each session. Posters are set in numeric order. Registrants may visit as many posters as they wish during the allotted time periods.

**Carousel Seminars (Round Tables):** A popular feature of the Conference designed to bring together small groups of people interested in discussing specific topics. Pre-registration and additional fees are necessary to attend carousel/rounds. The list of round tables is found on the enclosed registration form and in this program. Be sure to rank order 10 choices because these sessions fill fast. Requests are filled on a first-come-first-served basis, in order marked on the form.



# Ongoing Events

#### Exhibits -

Exhibits are located adjacent to the registration area and snack bar.

Attendees should plan to browse through the display of exhibits, books and other materials provided by publishers and other educational institutions, and see the latest in family materials. The program committee has planned some uninterrupted times throughout the week for exhibits.

NCFR President Hamilton McCubbin's reception will be located in the Exhibits Area. Attendees may then meet the authors of recent books. Wednesday, 4:30 - 5:30 p.m. - Closing of Exhibits. Plan to be in the exhibits area during this time. Prizes will be given, and only those in attendance will be eligible.

#### Film/Video Exhibits -

Monday, Tuesday, Wednesday, November 16-18, 8:00 a.m. to 6:00 p.m.; Peachtree Lane; Martha Calderwood, Chair.

Plan now to block some time for viewing the latest audio-visual materials. The film area is located in the balcony section of the ballroom (access by climbing the curved stairway in the exhibits area or enter from the 9th floor). The schedule and synopsis of entries will be included in the registration packets.

#### Snack Bar -


