<u>MRS.</u> JEWSON'S regular monthly narrative reports to Executive Committee members and Directors indicate a well organized office which is handling more NCFR business each month. THE JANUARY FINANCIAL REPORT is more favorable than was anticipated. A reason for this is that the Membership Development campaign, under the guidance of Mildred Morgan our President-elect, shows steady progress. YOUR BALLOT IS ENCLOSED Our Constitution requires a double slate. The Nominating Committee had scores of namessubmitted by mail to them for their consideration. They prevailed upon sixteen fine people to allow their names to be placed on this ballot. Most of the folk would prefer not 'to run against' the persons who oppose them, but that's the way it has to be. Who will serve NCFR's objectives best is the membership responsibility which is yours as you vote. Instructions about voting are on the ballot.

<u>A MULTI-PROFESSIONAL "FIRST</u>" The Illinois Maternal Welfare Committee is to be congratulated. It sponsored the First Illinois Congress on Maternal Care at Springfield, February 13-14. Registration exceeded expectations. Nearly eight hundred doctors, nurses, nutritionists, social workers, health educators and hospital administrators attended scores of round tables, even breakfast sessions were held. The organization of such a complex conference was remarkable. Nicholas J. Eastman, M.D. of John Hopkins, a principal participant, spoke on the topic, "The Multi-Disciplinary Approach to Obstetrics". Your President addressed three hundred and fifty at the dinner session using "Complete Maternal Care - A Family Affair" as his topic. The outstanding characteristic of the meeting was the way in which the medical profession gave its leadership for an interpretation to the other disciplines represented of "the team approach" to obstetrics. It was an excellent display of professional responsibility.

YOUR PRESIDENT, David B. Treat is attending the Illinois, Ohio and Missouri Council meetings this spring. Mr. Treat will represent NCFR at the National Catholic Welfare Conference meeting in Milwaukee, March 18-22 at the invitation of Msgr. DeBlanc, Director of the Family Life Bureau of the National Catholic Welfare Conference.

<u>A NEW NAME?</u> Most of the changes suggested by the Constitution Revision Committee chaired by Donald Brieland are simply in the interest of a more smoothly operating organization. NCFR membership would approve these in a routine manner. However, there is one major alteration.

The Committee has suggested a shift in name from The National Council on <u>Family Rela-</u> tions to The National Council on <u>Marriage and Family Living</u>. The Board of Directors at Boston last August conducted a straw vote which showed almost unanimous approval for such a shift. The Board believed some other changes were necessary and instructed the Executive Committee to consider these at the November 1956 Executive Committee meeting. The Committee made those adjustments and approved printing the proposed revision before the vote of acceptance or rejection by the membership. The suggested revisions will appear in the May Journal. Vote on the revised Constitution will be called for at the Annual Meeting in August at Purdue.

Reasons advanced by those in favor of the change of name were that "Relations" was more general than "Family Living" and "Family Living" coincided with the title of our Journal. On the other side are those who believe that the name of the Organization has become a symbol and that while it may not be exactly definitive, symbols are not lightly discarded. Another reason advanced for not changing the name is that a great many State and some Regional Councils have patterned their names on the original title of the Organization. Still there is not uniformity among the titles of State and Regional Councils. Some have said, "Would it be desirable to have all State and Regional Councils have a name patterned after the parent organization?" These people have suggested that the parent organization might ask for greater conformity in the phrasing of titles by State and Regional groups.

Give the matter careful consideration. Arrangements will be made for the voting in such a way that decisions will be made item by item, not "all or nothing".
