PRELIMINARY ANNOUNCEMENT - NCFR ANNUAL MEETING
Iowa State College, Ames, Iowa, August 19-21, 1959

THEME - GROWING INDIVIDUAL VALUES WITHIN THE FAMILY

Iowa State College and the Iowa Council on Family Relations are co-hosts for the annual meeting of the NCFR Aug. 19-21. By popular demand the Program Committee adopted the theme: Growing Individual Values Within the Family. A special effort is being made to carry this theme throughout the Conference. There will be four major presentations to the entire body of delegates, each followed by discussions in small groups: Conflict Patterns in American Culture; Values and Family Life; The Learning of Norms Through Great Literature; and Sex Ethics, Sex Acts, and Human Needs - A Dialogue. You are invited to send suggestions for discussion leaders. Feel free to nominate yourself.

Each of the eight sections of NCFR is carrying out the theme in each of its three sectional meetings. The themes for the sections are: COMMUNITY, "Community Responsibility in the Growth and Maintenance of Values"; PARENT EDUCATION, "Parents, Educators, and Values"; RELIGION AND THE FAMILY, "Religion in Personality Development"; COOPERATIVE NURSERY SCHOOL, "Co-ops, Families, and Values"; SCHOOLS, "Schools and the Growth of Values"; COLLEGE, "Values and the Marriage Course"; RESEARCH, "The Role of Research in Clarifying Values"; COUNSELING, "Value as Operative in Marriage and Family Counseling". You are urged to send papers or summaries of papers to be considered for the Section meetings. Indicate first and second choice of sections for your paper. Each paper should implement or be directly related to the theme of the conference.

A further effort will be made to tie everything together by the use of a conference reporter who will be busy at all times seeing that the conference as a whole is informed of what is going on in the various discussion groups and sections.

It is important to note the exact title of the theme. The emphasis is upon Growing Individual Values Within the Family context. Naturally, a good deal of time will be spent discussion various value systems, but this ought to take second place to the specific focus of the conference. We operate on the hypothesis that each individual must grow his own value system, but that many other people can be of help or hindrance to him in the process. The professional must assist the family in assisting the individual, as well as work with individuals. The underlying question of the entire conference will be how we, as professionals, organizations, and families, can help the individual grow a value system that will be increasingly meaningful for him as he lives in a complicated world.

The first presentation will be at 1:30 P.M., allowing time for arrival and registration the morning of the 19th. The final session will be Friday evening, the 21st, which will necessitate most delegates remaining over Friday night. The University is providing housing at \$2.00 per person per night in doubles, with a few singles available at \$2.50. Meals will be served in the college cafeteria. One evening picnic is being planned by the local arrangements committee. Advance registration checks, payable to the Iowa Council on Family Relations, should be mailed to Dr. William Kenkel, Local Arrangements Chairman, Iowa State College, Ames. WHITE HOUSE CONFERENCE ON CHILDREN AND YOUTH

Preparations for the 1960 White House Conference on Children and Youth are now underway all over the country. Three groups, The Governor's Committee in each state, The Inter-Departmental Committee on Governmental Agencies, and the Council on National Organizations, have the primary responsibility for coordination nation-wide suggestions for program and for materials to be printed for distribution at the Conference and afterward.

The Council on National Organizations for the White House Conference is composed of almost 500 member agencies, each of which appoints a permanent delegate to represent it on that committee. The NCFR is represented by Dr. Aaron L. Rutledge. In order to make the large committee functional, an Executive Committee of 30 people has been appointed to direct the activities of this Council and to take the leadership in organizing the suggestions and data which are collected. Our delegate is on that Executive Committee.

Dr. Rutledge urges that all suggestions or program ideas, and certain other information described below be rushed (in duplicate wherever possible) to Mrs. V. Jewson, NCFR, 1219 University Ave., S.E., Minneapolis 14, Minn., so it can be coordinated and worked together in a final report to be presented to the Council on National Organizations.

The material being requested includes any projects which have been completed or which are being completed by members of NCFR or by any state or regional Council on Family Relations. One focus of these reports will be research, but this need not be all that is sent in; there seems to be as much interest in the kind of study which outlines the undertaking of an organization in the general area of children and youth during the coming years. Any survey that shows what an organization has done, what it is committed to do, and what it is urging other organizations and groups to undertake is good material for this report.

Naturally, there is no guarantee that everything submitted will be used; but there is a strong indication that every valuable piece of data will play a part in the final report. Many reports will have to be consolidated, reviewed, and summarized; but some will be presented in detail. Since NCFR and the state and regional councils on family relations are virtually the only representatives of the family as a whole in all the national organizations, it is particularly important that we get in our valuable suggestions. Some people have wondered just how much of an impression suggestions will make or just how much use will be made of them in the final planning of the White House Conference. At the recent meeting of the Council on National Organizations in New York, the representatives of the White House Conference urged us repeatedly to submit this material, saying that they were depending almost exclusively on the three above-mentioned organizations for the planning of the White House Conference. To reinforce their dependency on the Council on National Organizations, the White House Conference Committee was represented there by Mr. Efram Gomberg, Director of the White House Conference; Mrs. Isabella Jones, Associate Director; Mrs. Oettinger, Secretary; and Dr. Ginzberg, Chairman of the White House Committee on Studies.

If we are to do justice to your reports, they should be coming in immediately, preferably most of them before April 1. There will still be time up until the last of August to make use of these materials. An NCFR committee will be working on whatever you send in, both at the Board meeting in April and preceding the Ames Conference in August.
