Dear NCFR Members:

The big news these days is the tremendous job we got into by accepting the challenge of a joint meeting with the International Union of Family Organizations. Although it is hard work, the challenge has been sufficient to keep us going. Now we are beginning to get our heads above water, and can see ways of making the IUFO-NCFR International Conference a reality. One of the biggest remaining problems is finance, with anticipated budget needs of \$19,000. In order to guarantee a sizeable delegation from Europe, the Conference Planning Committee agreed to help underwrite a chartered plane. One NCFR member gave \$500 toward this, and we hope this will challenge others to do likewise.

A few state councils are helping out financially. The Tri-State Council (New York and vicinity) under Wally Fulton's chairmanship, have accepted responsibility for local reception, entertainment and tours, and have put up \$500, as a down payment on those expenses. Jane Mayer, president of Tri-State, is chairman of the committee on translations and interpretation. Mark Flapan and Paul Vahanian are arranging for meeting places, housing, and other conveniences at Teachers College, New York City. Evelyn Duvall's committee has sent letters to potential international delegates all over the world. Esther Middlewood is setting up post-conference professional contacts for the foreign delegates. Ruth Jewson is in charge of publicity; Harold Christensen and NCFR section chairmen have a colossal job with program; Magr. Irving DeBlanc is organizing other American agencies which are IUFO members in joint sponsorship of the conference; David Mace has worn out one typewriter and two sets of fingernails liaisoning with Paris headquarters of IUFO; and yours truly is worrying about money.

The Planning Committee had to assign quotas of delegates from each sponsoring organization, including NCFR, and set a deadline of April 15 for registration. Total attendance expected is 1,200, with 300 spaces reserved for foreign delegates. It is imperative that NCFR delegates register at once if we are to guarantee that you can attend. Do it now, please!

An NCFR Executive Committee meeting will be held in Columbus, April 2 and 3, where many items of business will be discussed. Send items for the agenda to Ruth Jewson immediately.

Your president has been active as a Technical Consultant to the 1960 White House Conference on Children and Youth, has prepared one of the major papers "Marriage Problems and the Termination of Marriage", and will be a resource person for one of the work sections of the Conference. Ruth Jewson, Harold Christensen, and Mildred Morgan are also NCFR delegates.

See you in New York August 23-26, for our annual meeting and the International Conference.

The I.U.F.O., now nearly 12 years old, has eagerly longed for the day when it could hold a conference outside Europe. During the years since I saw its inception in Paris, it has grown into a sound and sturdy organization. It has member organizations all over the world. It possesses consultative status with E.C.O.S.O.C., with F.A.O., with U.N.E.S.C.O., with U.N.I.C.E.F., and with the Council of Europe. We may feel proud that in this sponsorship the NCFR is playing a leading part. It was the willingness of your officers to cooperate, by merging the NCFR annual conference with this larger venture, that really opened up the way for the dream to become a reality.

We hope that those of you who come to this Conference will get a taste of international thinking. You will hear people speak in languages other than your own (Translations will be provided!). You will be exposed to new ideas, new angles, new approaches. As members of the host country, it will be your privilege to make your guests welcome.

As yet we have no clear idea of how many overseas delegates will join us. Travel to this country is, alas, costly. But we want good representation from abroad, and will work hard to get it. One special way in which you can help is by inviting foreign students, exchange teachers, visiting professors, and specialists who are interested in the family—especially those from distant lands which might not otherwise be represented. Will you make this your special concern?
