## ANNUAL MEETING

Plans for the program for the NCFR 1965 conference to be held in Toronto, October 21-23, are well underway and will be announced in detail in May. In the meanwhile, Ivan Nye, program chairman, has already sent preliminary information to whet our appetites. The theme is "The Family in Context." The opening session Thursday morning will be on the family and the medical profession. Frank Lock, M.D., president of the American College of Obstetricians and Gynecologists, will be the opening speaker. Ethel Nash, Bowman Gray School of Medicine, will chair that session, and is also selecting a second speaker. This session will be followed up in the afternoon with a panel and discussion in the Special Emphases section.

The second plenary session is still being planned. It may be devoted to the family in cultural context, with a Canadian and an American speaker; but more about this later.

Reuben Hill, Professor of Sociology and Director, Minnesota Family Study Center, University of Minnesota, will deliver the Burgess Award address at the third plenary session. He will discuss the present state of family theory and expected developments.

The conference will close with a banquet and the Presidential Address given by Clark Vincent. This is a year when no one will want to leave the conference ahead of the last session.

The Section programs will be excellent. The Research fare is not only voluminous but unusual as well, with panels on inter-disciplinary research and new areas for research as well as ten research papers. Ira L. Reiss, Dept. of Sociology, University of Iowa, is Research Section Chairman.

One of the panel discussions is entitled "New Frontiers of Family Research." Participants in this panel, chaired by Wallace Fulton, Equitable Life Assurance Society, include Carl Broderick, Pennsylvania State University; Jessie Bernard, Washington, D.C., Sociologist; Mary Calderone, M.D., Sex Information and Education Council of the U.S.; Donald McKinley, Teachers College, Sociologist; Isadore Rubin, Sexology Magazine; and Edwin Schur, Tufts University, Sociologist.

A second panel will discuss "Is There a Value to the Cross-Disciplinary Approach to the Family." Participants will be Robert Bell, Temple University, Sociologist; Evelyn M. Duvall, Family Life Consultant, Chicago; Eleanore Luckey, Dept. of Child Development and Family Relationships, University of Connecticut; David Mace, American Association of Marriage Counselors; Vladimir de Lissovoy, Dept. of Child Development, Pennsylvania State University; and Reuben Hill, Family Study Center, University of Minnesota, Chairman.

Research Section papers include: Milt Fuller, University of Iowa, "A Study of Marital Suicide;" Lucius Cervantes, St. Louis University, "The Isolated Nuclear Family and the Dropout;" Kathryn

Hobbs, Jr., University of Florida, "Transition to Parenthood;" Dwight G. Dean, Denison University, "Emotional Maturity and Marital Adjustment."

Paul Vahanian, Teachers College, Columbia University, is Counseling Section Chairman. He has announced discussion of the following three stimulating and informative themes:

"The Marriage Counselor in the Physician's Office," Richard Klemer, University of Washington.

"Alterations in Approaches to Families: Implications of Variations and Treatment," Marvin Goodman, Chief Psychologist of the Saginaw Valley Child Guidance Clinic, Saginaw, Michigan.

A session on family centered counseling, with speakers yet to be selected.

Bill Marshall, Dept. of Child Development, Michigan State University, is Education Section Chairman. This section has six meetings scheduled, all of which sound most exciting. The first session is entitled "The Family in Context - Classroom Approaches." Morey and Clara Appell, Indiana State College, have as their topic "Attitudinal Changes Toward the Disadvantaged Child and Family." John R. Crist, Denison University, will speak on "The Existential vs. the Operational Approach to Teaching Marriage and Family Courses," with Laurence H. Lang, Merrill-Palmer, as discussant.

The second session will be devoted to a report of the NCFR Standing Committee on Standards and Certification of Family Life Teachers." Elizabeth Force, American Social Health Association, Chairman, and committee members will take part.

"The Family in Context - Study of the Family through Creative Literature," is the theme of the third session. Rose Somerville, Teacher Exchange Editor, Journal of Marriage and the Family, will discuss the short story; Laurence E. Smardan, San Jose State College, has drama as his topic. A third participant will discuss the novel.

The next Education session is entitled "The Family in Context - Contributions to Understanding." Beatrice Paolucci, Michigan State University, will present a paper on "The Contributions of Home Management Theory to the Teaching of Family Relations." Discussants will be Arleen Otto, Teachers College, and Helen Westlake, East Leyden High School, Chicago.

Rose Somerville will preside at a Luncheon Discussion on Saturday, sponsored by the Education Section. Readers of the Teacher Exchange will be given an opportunity to suggest ways in which this section of the Journal can be made more useful.

The final Education Section meeting on Saturday afternoon will be devoted to film previews, with James Walters of Florida State University presiding.

William Carroll, Flint Community Junior College, Flint, Michigan, Chairman of the Special Emphases Section, is planning some provocative sessions also. The first meeting will be a discussion of "The Family and the Medical Profession." Other topics to be studied by participants of this section are: "Planned Parenthood - International and Interpersonal;" "Religion - National and Local Concerns;" and "The Use of Sex in Human Life." Speakers will be announced in the May Newsletter.

The conference will be held at the Park Plaza Hotel in Toronto; and the Local Arrangements Committee, with Frank Fidler, Board of Christian Education, United Church of Canada, Toronto, as Chairman is hard at work to make it very pleasant. Several social events are planned, allowing ample time for visiting. Benjamin Schlesinger will be responsible for the Book Display. The hotel will correspond with each NCFR member regarding room reservations. In addition, the Chamber of Commerce in Toronto will send everyone information about the city during the summer.

NCFR - RUSSELL SAGE FOUNDATION PROJECT

In the November Newsletter we announced that the Russell Sage Foundation has awarded a grant to the NCFR to prepare a special issue of the Journal of Marriage and the Family consisting of several papers on "The Impact of Governmental Programs on the Family: Problems, Prospects, and Implications for Social Policy." Marvin B. Sussman, our editor, was appointed to take charge of the grant and of preparing the issue. An initial one-day planning session has been held, with the following persons in attendance: Catherine S. Chilman, Children's Bureau, Dept. of H. E. W.; Nathan E. Cohen, Professor, School of Social Welfare, University of California, Los Angeles; Howard E. Freeman, Brandeis University; Alvin L. Schorr, Social Security Administration; Otto Pollak, University of Pennsylvania; Stanley Wheeler, Russell Sage Foundation; Marvin B. Sussman, Western Reserve University; Clark Vincent, Bowman Gray School of Medicine. The Committee's deliberation and discussion were very productive and culminated in an outline for the Special Issue of the Journal, and excellent choices of authors, as well as critical readers for the papers.
