## ANNUAL MEETING - TORONTO, OCTOBER 20-23, 1965

Dear Colleagues:

Canada has just obtained a new flag, we also have our own "War on Poverty," "Peace Corps," and a ten per cent income tax cut. Add to this that the NCFR will hold its first meeting in Toronto, and what else can you ask for?

Toronto has about 1½ million people, we are building our 40 million dollar city hall, and boast of our cosmopolitan flavour. Toronto is not a suburb of Montreal, and French is not spoken in most places of interest. As part of your stay, you will be living at the Park Plaza Hotel, a very nice hotel, which offers good service and good Canadian hospitality. I am sorry that you could not get the fancy brochure from the hotel (they cost 35¢ each), but if you mail the reservation card enclosed with this newsletter, you'll get a brochure free of charge.

Frank Fidler, the chairman of local arrangements, has been very busy making sure that all of you will have a chance to be indoctrinated with Canadiana. Among the plans are: 1. A tour of Toronto 2. Visits to the Royal Ontario Museum (free of charge to NCFR delegates) 3. A film night, featuring the best Canadian films of the National Film Board of Canada, on "see Canada through films" 4. A dinner at "Hart House" of the University of Toronto, followed by a folk music concert of Canadian and international songs, given by one of our best performing groups 5. A visit to Casa Loma, our own castle 6. A government reception for the delegates 7. Walks around our own "Greenwich" village called Yorkville, situated next to the hotel 8. etc.....etc.....etc.....

The Canadian Broadcasting Corporation has also shown an interest in our conference, and we hope that they will tape some of our sessions, to be broadcast Cross-Canada. Our television network (one of the best) may even televise some of our luminaries in action.

I had a chance to meet with the NCFR executive committee in Philadelphia in April, and they are also excited about the conference. We, here in Toronto, hope to see you next October and to greet you personally. Please write to us, if you have any special problems (such as money for your fare), and we will refer you to the appropriate American Foundation.

P.S. Some hints for visitors: You can get to Toronto by car, train, or plane. a) If you arrive at Malton Airport with 2-3 other delegates you can take a limousine for \$6.50 directly to the Park Plaza, or take the Airline Bus for \$1.50 to the Royal York Hotel, and a taxi to the Park Plaza for about \$1.25. b) Plenty of parking is available at the Hotel. c) Money - Try to obtain about \$10 in Canadian money in the United States; the rest you can exchange in the bank located in the Hotel. The exchange rate varies from 7-8 per cent on the dollar (i.e. one American dollar is \$1.07 Canadian). d) Food - Meals are less expensive in Toronto than in New York.

## MEMBERS' ACTIVITIES

RUTH HOEFLIN has been spending a sabbatical at Merrill-Palmer, with trips to Ohio State, Bowling Green, Penn State, and Michigan State Universities. She will return to Kansas State in early June.

PAUL C. GLICK, Assistant Chief, Population Division, U.S. Bureau of the Census, is President-Elect of the Population Association of America.

JEROME D. FOLKMAN, Rabbi, Temple Israel, Columbus, Ohio, is teaching "Factors in Successful Marriage" at Ohio State University, where he holds the rank of Adjunct Professor.

EVELYN MILLER BERGER, East Bay Psychological Center, Oakland, California has appeared on a TV series entitled, "Family Forum" for the past 3 months over Station KRON in San Francisco. She wrote scripts and is now working with Cathedral Films, Burbank, on production of filmstrips on "Problems of Teen-agers."

GERALD ALBERT, Assistant Professor of Counseling at the C. W. Post College of Long Island University, has been named Director of Guidance and Counseling at the college.

MIRIAM PROCTOR, N. Y. City Psychotherapist, has been doing some research with Dr. Thomas Langner of New York University Medical School. Her job has been to interview mothers with children from 3-18 years of age. Hopefully, a grant will make it possible to continue the project.

FLOYD M. MARTINSON, Gustavus Adolphus College, St. Peter, Minnesota writes that copies of a study, "The Pastor as Counselor," recently completed by the Department of Sociology at Gustavus Adolphus College are available; and abstracts of two sample surveys, "High School Marriages in Minnesota" and "The Provisions for the Education of Teen-Age Unwed Mothers in Minnesota High Schools," are available by writing him.

FLORENCE KERCKHOFF, Director of the National Child Research Center, Washington, D.C., and RICHARD KERCKHOFF, Washington School of Psychiatry were coordinators for the second annual conference, May 6-7, 1965, entitled "Children Under Six: Crucial Issues in Education for Today's World." Co-sponsors were their respective institutions. The meeting was an invitational one for 18 leading national authorities in fields related to the education of young children.

RICHARD KERCKHOFF, Washington School of Psychiatry, will direct an invitational conference on activities programing for the chronically ill, particularly the elderly, June 3-4, 1965, at his institution. Representatives of 20 national agencies active in such programs will attend.

JOSEPH S. DARDEN, JR., Health Education staff, Newark State College, Union, New Jersey, presented a paper on "Family Living as a Part of the High School Health Education Curriculum" at the Eastern District Conference of the New Jersey Association for Health, Physical Education and Recreation in March.

MAX RHEINSTEIN, University of Chicago Law School, will be in Germany April 23 - July 31, 1965. From August 1, 1965 - June 30, 1966, he will be at 35 Hamilton Court, Palo Alto, California.

ETHEL M. NASH, Bowman Gray School of Medicine, took part in a conference on the Social Responsibility of Gynecology and Obstetrics at Johns Hopkins Hospital in May. Topics discussed at the conference included the quantity of the next generation, the quality of the next generation, the pregnant schoolgirl, the law, abortion, contraception, sex education, adoption - family welfare, educating the physician for his role.

VERA AND DAVID MACE have been working since 1960 on an extensive study of family problems in the Caribbean, for the World Council of Churches. They have made five separate visits to the Caribbean, covering almost all the territories. Their program culminated last summer in a five-week Seminar on the island of Antigua, with a group of twenty picked delegates from all the major Caribbean territories. Out of this Seminar, the Report of which is to be published soon, there came a proposal for a long-term follow-up project. The plan is to hold three training Seminars, lasting a month each, and each with twenty to twenty-five delegates, each year for the next five years. In this way, over the five year period, a new nuclear group of several hundred people will be given basic training, and they are expected to begin to develop family life programs in all the Caribbean communities. It has been the Mace's responsibility to set up the three Seminars for this summer, the first year of the five-year plan. Through Bill Genne's Department of Family Life, they have been able to get excellent leadership. Bill and Betty Genne themselves will be the leaders at the Western Caribbean Seminar, in Jamaica. David and Frances Treat will be leaders of the Eastern Caribbean Seminar, in Barbados. J. C. Wynn and Clark Ellzey together will be leaders of the Southern Caribbean Seminar, in Trinidad. All Seminars will be held in August.

SYLVIA S. THEA is the director of the Marriage Counseling Service of St. Louis County Court of Domestic Relations, the first Court oriented Conciliation Service in Missouri. The number of requests for marriage counseling filed with the service has increased steadily. At present, the service is limited to St. Louis County couples who have a divorce petition on file. In a few cases, other couples who indicated that they will be divorce bound without some help and who for a given reason are unable to work with a private marriage counselor or with one of the agencies are also seen. Local attorneys have been extremely interested and cooperative. By the end of the first year 199 different attorneys had used the services of the office. A paper presented by Mrs. Thea to an interdisciplinary professional group summarizes the highlights and presents certain questions for consideration based on the cases coming to the Marriage Counseling Service in the first 9 months of its operation. Mrs. Thea welcomes correspondence from other jurisdictions having a court oriented conciliation service.

CARL C. ZIMMERMAN, Distinguished Professor of Rural Sociology, North Dakota State University, coordinated the program for a Great Plains Symposium, April 20-22, sponsored by the North Dakota Institute for Regional Studies as one of the events commemorating the 75th Anniversary of the State University. In addition to addressing the conference twice, he provided the final summary at the closing session. He has also spoken to GLADYS GROVES' class in the College of Home Economics.

MARY E. HELTSLEY, Assistant Professor of Family and Child Development, Georgia Southern College, will be at Ohio State University next year to continue to work on her Ph.D. in Family and Child Development under the direction of Christine Hillman.

DONALD TAYLOR is on sabbatical leave in Europe. His address is Klausenerplatz 24, Munich 9, Germany. Dr. Taylor is planning to attend the IUFO meetings in Rome.

EARLE E. EMME'S "A New Ten Commandments for Parents" was published in THE CHRISTIAN HOME in November, 1964. Dr. Emme's address is 1724 Crystal Lake Drive, Lakeland, Florida.

WAYNE J. ANDERSON, University of Minnesota, has an article on "Ideals Can be Disquieting" in the May, 1965, PTA Magazine. Dr. Anderson's present research is entitled "Sex Education Inventory, A Study of the Sources and Adequacy of Your Sex Knowledge." Two thousand college students are comprising the sample.

S. C. LEE, Associate Professor of Sociology, University of South Dakota presented a paper entitled "Marriage and Family Life under Religious Communalism in South Dakota" at the Midwest Sociological Society Annual Meeting April 23. The paper is a portion of an empirical study being carried out under the auspices of the NIMH. Many fundamental issues concerning marriage and the family are raised and discussed. Audrey Brattrud, senior sociology major, is Dr. Lee's assistant.

AMRAM SCHEINFELD'S new book, YOUR HEREDITY AND ENVIRONMENT, J. B. Lippincott Co., gives detailed attention to many subjects of importance in the fields of marriage and family-living. Succeeding the author's well-known book, YOU AND HEREDITY, the new work is more comprehensive, reflects new findings, and goes into more detail regarding the interaction of hereditary and environmental factors in producing human developmental, pathological, and behavioral traits. Separate chapters are devoted to Personal Problems of Heredity (parenthood, parentage), Social Behavior, Sexual Behavior, Crime, Intelligence, Talents and many topics relating to children.

ELIZABETH S. FORCE was the keynote speaker May 15th for an all-day workshop sponsored by the Family Life Department of the Church of the Valley, Santa Clara, California. Theme: "Meeting Changes in Family Living." CLARENCE M. ANGEL is Family Life Education Director for the Church of the Valley.

DOROTHY T. DYER has been directing an 8 week course in group leadership dynamics at the Church of the Valley. Seventeen mothers and fathers are enrolled. They were leaders at the May workshop at which Mrs. Force spoke. After a refresher course in the summer, they will be ready for the expansion of the church's fall program.

CLARENCE M. ANGEL described the Church of the Valley's projects at a Santa Clara County Coordinating Luncheon in April. DOROTHY DYER, DAVID TREAT, CLARENCE ANGEL, GEORGE KANDLE and others are behind a big push for Family Life Education in the county.

BLAINE R. PORTER, B.Y.U., delivered an address entitled "Family Life Education at Mid-Century" on February 8th at Oregon State University. This was the first lecture in a series sponsored by the University under the general heading, "Human Relations at Mid-Century." Other speakers in the series included Dr. Alan F. Guttmacher, President of Planned Parenthood and World Population; Michael Harrington, author of "The Other America;" and John T. Rule, Massachusetts Institute of Technology.

ISADORE RUBIN, Managing Editor, Sexology Magazine, is the author of "Sexual Life After Sixty," to be published by Basic Books, in May. It is the first such book covering this age group. For the spring

issue of "The Humanist," which is devoted to sex, Dr. Rubin prepared "A Basic Humanist Bookshelf on Sex."

CLARK VINCENT, ISADORE RUBIN, LESTER KIRKENDALL and BEN ARD gave papers at the University of Calif. School of Medicine (San Francisco) Symposium, "The Uncertain Quest: The Dilemmas of Sex Education," April 10-11. Dr. Rubin's paper was entitled "The Community and the Responsible Teacher."

HAROLD FELDMAN, Cornell University, has published a research report entitled "Development of the Husband-Wife Relationship." The study developed from a long range interest in the nature of the husband-wife relationship as it may change over the life cycle of the marital pair.

EDA LE SHAN, consulting psychologist, New York, is author of "How to Survive Parenthood," Random House.

DOROTHY WHYTE COTTON, editor in chief, Parents' Magazine, is the author of "The Case for the Working Mother," just published by Stein and Day.

CATHERINE CHILMAN, Research Division of the Welfare Administration, is working on research planning in the area of prevention and treatment of chronic dependency.

ROSE SOMERVILLE, City College of New York, was moderator recently at an international program for guests from Scandinavia sponsored by the Human Relations Center of the New School for Social Research. She also was a panelist at a workshop on the Family and the Child at the League for Parent Education's Annual Conference in March. The overall theme was "Who Rears the Child?"

ROBERT G.
