



The motivation and consequences of behavior in courtship and marriage have been dissected by scores of social scientists in countless useful and revealing studies. In THE SOCIAL CONTEXT OF MARRIAGE, Professor Udry skillfully clarifies recent behavioral research findings and presents fresh interpretations in an always instructive and occasionally provocative manner.

The author's approach is basically systematic and analytic, making liberal use of case histories to illustrate concepts and conclusions and to bridge the gap between general propositions and the realities of personal life.

Social-psychological aspects of masculine and feminine sexuality are explored with straightforward sophistication. Sexuality in general and heterosexuality in particular are viewed as socially developed behavior patterns with drives induced by social experience. The implications of this approach for social control and for individual attitudes toward sex are carefully probed and analyzed.

While the book addresses itself principally to middle-class American social patterns, cross-cultural material is frequently included to provide perspective for the student.

Presenting his material in a style that is consistently clear and easily grasped, Professor Udry makes it possible for the student who has not previously been exposed to courses in the social sciences to gain valuable insight into the complexities of heterosexual interaction in contemporary American society.
