NEWS FROM THE NCFR EXECUTIVE COMMITTEE MEETING

The NCFR Executive Committee met in Washington, D.C., January 7-8. Guests at the first session included: Dr. David Kallen, NIMH; Mr. Alvin Schorr, OEO; Miss Jean Reynolds and Miss Frances Shoun, Children's Bureau; Dr. Carl Schulz, Public Health Service; Dr. James Lieberman, NIMH; Miss Martha Branscombe, Headstart, OEO; and Dr. Barbara Chandler, Office of Education. They reviewed some of their work, and told of some of their concerns in the family life area.

William M. Smith, Jr., general program chairman for the 1966 Annual Meeting in Minneapolis, announced the following theme for that conference: <u>Family Potentials in a Cybernetic Culture</u>. A motion was passed that Proceedings of NCFR annual conferences be published and made available, with the Program Chairman serving to coordinate and publish the proceedings; and that the cost of this service should be as self-sustaining as possible.

The addition of a theory section was discussed. A motion was passed that theory emphasis be combined into the existing Research Section, and that the section be called Theory and Research Section. A motion was also passed that an associate chairman be appointed to carry the burden of the theory emphasis. Roy Rodgers was selected for this responsibility.

The following report was read from Evelyn Duvall: Professor Pierre de Bie, Chairman of the Scientific Commission of the IUFO, is circulating working papers on the establishment of the work and membership of the commission, and soon will be calling a preliminary planning meeting, in which we will participate. The check from NCFR for \$1,000 authorized by the October board has been sent Dr. de Bie, with an urgent request that it be matched by funds from European sources for the establishment and work of the commission. An exchange of letters with M. Guibourge on the subject is underway. The International Conference on the Family will be held in New Delhi December 12-17, 1966.

Murray Straus was appointed the new chairman of the Mass Media Committee.

A motion was passed accepting the unanimous recommendation of the Ad Hoc Committee on Journal Editorship that Dr. Marvin B. Sussman be reappointed editor for an additional period from December, 1966 to December, 1969.

The NCFR has been asked to send a representative to the Conference of Population and Housing Census users. David Heer, School of Public Health, Harvard University, was appointed.

OSBORNE TEACHING AWARD

In memory of the late Ernest G. Osborne, the National Council on Family Relations establishes an Osborne Teaching Award. Bi-annually a \$500 award is to be given to an individual in recognition of his demonstrated excellence in the teaching of family relationships.

Any individual may make nominations to the Award Committee by completing the form provided. (Nominations are not to be self-initiated.)

Policy

- Teaching is to be interpreted as inclusive of educational programs in religious organizations, Adult Education, Extension, free-lancing, as well as instruction in elementary and secondary schools, colleges and universities.
- 2. The "teaching of family relationships" shall be defined rather specifically as "education about and for improvement in interpersonal interaction between or among family members." It should be distinguished from broader or more explicit instruction which may be of value in family relationships but does not have relationships within the family as its principal focus (examples of the latter: family finance, health education, personal development, etc.).

Criteria for Nomination

- Demonstrated excellence in the teaching of family relationships. (Documentation will be necessary.)
- Currently engaged in and probable active future role in the teaching of family relationships.
- Excellence in learner-teacher relationships, including the qualities of empathy, acceptance of the individual, and active concern for the learner's total growth and development.
- 4. Willingness to promote dissemination of knowledge about improved teaching of family relationships through presenting a paper at an NCFR meeting and/or seeking publication of such in the JOURNAL.
