The United States Employment Service and its affiliated state agency in Minnesota will cooperate with the NCFR in providing placement service at the annual meeting in Minneapolis in October. The Placement Center will be located on the Mezzanine, Rooms 215-207, Leamington Hotel.

The United States Employment Service has developed an efficient Professional Convention Placement Service which has in recent years been furnished to many professional organizations, such as the American Sociological Assn. This will be the first time the NCFR has used this service.

If you are seeking employment or are an employer having unfilled job openings, you may be interested in using this placement service. For your convenience the Minnesota State Employment Service is accepting pre-convention placement registrations by mail. Registering your job openings or application for work prior to the annual meeting will expedite service at the Placement Center. Those unable to attend the annual meeting are also encouraged to register.

In completing the enclosed placement application and/or job order registration forms, please provide adequate details on the forms themselves rather than submitting additional resumes. In order to facilitate the necessary duplicating process, it is suggested that the forms be typed or that black ink be used if prepared by hand.

These Placement Center registration forms will be filed in binders for open review by interested employers or applicants attending the annual meeting. Should you desire anonymity, please attach a note to your form and all identifying data will then be deleted from copies made available for review.

MESSAGE FROM THE NCFR PRESIDENT, F. IVAN NYE

As I wrote you last December, the challenge this year is effectively to utilize the additional financial resources now available to us to develop new programs in the NCFR which will even better serve the needs of our members, and to whatever extent possible, to improve the family group so that it fulfills even more effectively the needs of family members. Toward these objectives three actions have been taken:

First, the addition of an International Section of 32 pages has been approved for the Journal of Marriage and the Family to bring the most creative work of foreign scholars to American readers. Editor Marvin Sussman is negotiating for a distinguished European scholar as editor of this new section.

Second, a series of six-week summer workshops in Family Life Education for public school teachers is under consideration under the sponsorship of NCFR. A special Ad Hoc committee has been appointed to develop specific proposals: FREDERICK BERGER, BARBARA CHANDLER, CARLFRED BRODERICK, ELIZABETH FORCE, RICHARD HEY and ELEANORE LUCKEY, Chairman.

A third additional program may involve a second journal to be published by NCFR to supplement the Journal of Marriage and the Family. This would be an applied journal designed to develop materials, ideas, and strategies more directly applicable to family problems. President-Elect WILLIAM SMITH has agreed to head a temporary committee to generate ideas concerning it. Other members of the committee are: EMILY MUDD, AARON RUTLEDGE, JUDSON LANDIS, WILLIAM MARSHALL, ROSE SOMERVILLE, ROBERTA FRASIER, L. FRANCES JORDAN, CATHERINE CHILMAN, THEODORE JOHANNIS, JR.

We would like your ideas and opinions. If these relate to possible workshops, send them to ELEANORE LUCKEY; if they relate to a possible second journal, send these to WILLIAM SMITH. If you have other ideas for new programs you feel would be desirable, send them to RUTH JEWSON or to me.

I hope most of you are planning to attend the Annual Conference in Minneapolis, October 27-29. Program Chairman WILLIAM SMITH and his colleagues have arranged a tremendous program. See you there!

BRIEF EXCERPTS FROM A REPORT PREPARED BY MRS. COLLINS, IUFO REPRESENTATIVE AT THE U. N.

The General Assembly's 20th Session completed and adopted the Convention on the Elimination of All Forms of Racial Discrimination. It is the first U.N. Human Rights Treaty to include implementation measures...The Sub-Commission on Human Rights studied the draft report of Discrimination Against Persons Born out of Wedlock. The consensus appeared to be that the study as presented was overly "legalistic" and not representative of actual conditions prevailing in many member nations of the UN. ...Helena Z. Benitez of the Philippines, new Chairman of the Commission on the Status of Women, presided over the 19th session. A draft declaration on the elimination of discrimination against women was adopted...The UNICEF Executive Board Meeting met in Ethiopia. Two papers of special interest were entitled, "Assessment of Family and Child Welfare Programmes" and "Family Planning"...The Report on the World Situation given at the 17th Session of the Social Commission dealt with the attitudes, values, and new structures that are emerging...A Conference of Ministers Responsible for Social Welfare has been suggested for 1968, to discuss social welfare programs...A new publication entitled "Family, Child and Youth Welfare Service," Sales #65, IV 4.9. Document #5T-SLA-59 is available for 75¢ from Sales Publications, United Nations, N.Y. 10017. It will be of interest to family casework personnel as well as to those concerned with marriage counseling and family life education. ..NCFR members interested in reading Mrs. Collins' report in its entirety may write the NCFR office.

A Family Life Conference featuring PAUL POPENOE, Founder and President of the American Institute of Family Relations, was held in Rock Springs, Wyoming in May. His opening address was entitled, "What is Happening to the Family?" NCFR member JOSEPH MANN, Director of the Southwest Counseling Service in Rock Springs, was co-chairman of the Conference.

A national study of family credit counseling services throughout the country is now being conducted under the direction of the Family Service Assn. of America. Perry Hall, Asst. Director of the National Study Service will be field director of the project.

To provide a medical and sociological perspective on current student sexual behavior and its implications for college health service personnel, a three day symposium on Sex Education of the College Student will be conducted at Pennsylvania State Univ., Oct. 19-21. It is open to college and school health physicians and nurses, social and health workers, and interested educators. Among the speakers will be Warren R. Johnson, Univ. of Md., on "The College Responsibility;" and WILLIAM GENNE, National Council of Churches, on "Our Moral Responsibility." ARTHUR GRAVATT, Penn State Univ., symposium chairman, will summarize the discussions at the final session.

The American Association of Marriage Counselors will hold a one-day conference on the training of marriage counselors immediately following the NCFR Annual Meeting. RICHARD HEY and GERHARD NEUBECK are program chairmen...The AAMC Annual Meeting will be held in Los Angeles, at Thanksgiving time... The Directory of Members of the American Association of Marriage Counselors for 1966 is now in print.
