## FROM THE NCFR PRESIDENT, WILLIAM F, KENKEL

There were three men went down the road  
As down the road went he

And so it is with organizations. As we look at the accomplishments of this one year we are forced to admit that they are in no small measure the result of the hard work and devotion that has characterized our organization for so many years in the past. More unnerving, from the standpoint of your president, is the recognition that what happens in 1967-1968 will have its ramifications, whether for good or for ill, on the future of N.C.F.R.

1966-1967 was a good year for N.C.F.R. Ruth Jewson, our able and untiring executive officer, has the financial data which attest to the health of our organization and, more important, the membership data which indicate we are increasingly meeting the needs of more professional people. While in any ultimate sense the success of the annual meeting must be attributed to the membership, their interest and support were stimulated by the section programs selected by the chairmen: Harold Christensen, Gerald Leslie, Esther Middlewood, and Jay Skidmore. Thanks to Murray Straus, summaries of the papers are available in the conference proceedings. The Film Sessions, arranged by Jim Walters and supervised by Joseph Maxwell, were well attended. Probably each person will remember the San Francisco meeting best because of one event or feature. Some will remember it as the year that luncheon dialogues were initiated under the skillful coordinating leadership of David Fulcomer. Others will for a long time recall the sincerity of the Hippie Panel as they tried to communicate to us their views on love, marriage, sex, and child-rearing. No doubt all will often recall President William Smith's inspiring address, "Family Relationships: Communicating a Concept," just as they will long remember the smooth functioning of local arrangements and the special events worked out by Ruby Dean Harris and her committee.

Between annual meetings your Executive Committee will meet at least twice to take care of the ongoing business of N.C.F.R. In keeping with the theme of the last annual meeting, we will strive to communicate the high points of the meetings. On the agenda for the December 1st session in Washington is the continuing question of the relationship between local, state, and regional councils and the national organization. The Executive Committee will again meet with key people from the various federal government agencies concerned with families, children, and youth to learn of their programs and to advise them of N.C.F.R.'s willingness to be of service.

All N.C.F.R. members have reason to be proud of our two journals, The Journal of Marriage and the Family, edited by Marvin Sussman, and The Family Coordinator: A Journal of Education, Counseling, and Services, edited by Bill Smith. Together and in a complimentary fashion they serve as effective ways to communicate important and current ideas, findings, issues, and theories in the field of marriage and the family. The editors deserve not just our thanks but our continued and wholehearted support. We are looking forward to the special issue of the journal on "Family Planning and Fertility Control."

N.C.F.R.'s 1967-1968 year will come to a close with the annual meeting in New Orleans, October 16-19, Elizabeth Force, President-Elect and Program Chairman, has selected the conference theme "The Man and His Worlds." There are indications already that this will be one of our most successful conferences. Don't be left out.

Years ago I was attracted to N.C.F.R. because I saw it as a concerned organization. It was concerned with quite real problems of quite real families. It was concerned with strengthening the bases for gaining sound knowledge about marriage and the family. It was concerned with its members, their wishes, their interests, and their needs. THE HIGHLIGHTS OF THE NCFR ANNUAL BUSINESS MEETING AUGUST 19, 1967

MARVIN SUSSMAN, editor of the JOURNAL OF MARRIAGE AND THE FAMILY, indicated that two special issues are in the offing--one on Family Planning and one on Cross-National Research.

BLAINE PORTER reported on the 1967 Osborne Award which was presented to HENRY BOWMAN, University of Texas.

RUTH JEWSON reported on the special committee on Curriculum Development, chaired by JAMES WALTERS, indicating that the work of this committee is divided into five categories: 1. Emerging ideas concerning family life education; 2. Steps in establishing a family life education program; 3. Considerations to keep in mind for a critical look at programs and/or materials in family life education; 4. Recommended materials to aid in curriculum development; 5. Standards for Family Life Education Teachers.

CLARK BLACKBURN reported on the IUFO International Convention in New Delhi and announced the International meeting in Quebec this fall. It has been suggested that there be a regional office for North America and later, continental offices for each continent.

AARON RUTLEDGE, Merrill-Palmer Institute, reported his experience as a member of a committee involving the World Conference of Churches held near Geneva. Hopefully, a clearing house will be established to aid small areas.

RUTH JEWSON read the report sent by Evelyn Duvall, Chairman of the International Liaison Committee. Dr. Duvall has proposed that as many NCFR members as possible sponsor membership for foreign colleagues by paying their annual membership fees and then maintain close contact by correspondence, sharing problems, resources, and ideas.

The NCFR will begin publication of FAMILY COORDINATOR: JOURNAL OF EDUCATION, COUNSELING AND SERVICES in January, 1968, having concluded an agreement with the E. C. Brown Trust Foundation of Portland, Oregon, to acquire the Foundation's 16 year old quarterly, the FAMILY LIFE COORDINATOR. The NCFR's new venture is designed for the professional-in-action, and is especially concerned with education, counseling, and services in the family life field. WILLIAM M. SMITH, JR. is Editor.

The treasurer's report was presented. The total income for the year of 1966 was \$89,818.15. The total income for 1962, by comparison, was \$41,087.40. The projected budget for 1968 is \$112,583. The Burgess Award Fund consists of 309 Growth Industry Shares worth, at present, \$7,174.98 plus interest to the amount of \$2,004.88. The Osborne Award contains a balance of \$10,809.25, plus \$210.00 in outstanding pledges.

RUTH JEWSON reported that office space has been increased. We were unable to purchase a building as planned last year, because the zoning could not be changed.

The membership, as indicated by journal circulation, has increased from 5,500 in June 1966, to 6,700 in August 1967. The circulation to non-members has also increased.

A report from the NCFR representative to the American Home Economics Association, WILLIAM MARSHALL, was presented. The AHEA plans to continue work on the collections of abstracts of dissertations pertinent to the family life field. It was suggested that the NCFR and AHEA jointly sponsor a graduate conference addressed to the issue of graduate training.

IVAN NYE announced the members of the Publications Board. They are: MURRAY STRAUS, Chairman; BLAINE PORTER; AARON RUTLEDGE; ROBERTA FRASIER; IVAN NYE; MARVIN SUSSMAN, Ex Officio; and RUTH JEWSON, Ex Officio.

A motion made by J. OBERT KEMPSON, representing affiliated groups, was carried: That the Executive Committee appoint a committee to define affiliated groups and to develop standards and guidelines for such groups; that this committee be instructed to prepare a structure which would lead to complete local affiliation including the relationship of the local representatives of the agencies affiliated on a national level, and that such a structure be incorporated into the by-laws of NCFR; that NCFR set up a speaker's bureau, including names and suggested areas of discussion and send this information to regional, state, and local councils; that NCFR distribute a resume of the two meetings of the Affiliated Groups Seminar to all regional, state, and local councils.

STATE, REGIONAL, AND LOCAL COUNCILS

The SOUTHEASTERN COUNCIL regional meeting will be February 25-27, 1968, at the Francis Marion Hotel, Charleston, South Carolina. The theme will be "Marriage Today." Recommendations in their recent newsletter included the following: 1. Continuation of the research project, "Problems of Low Income Families;" 2. Education and certification of teachers in Family Relations (a. Seek State Board of Education approval for the certification of teachers in Family Relations; b. Encourage colleges to offer courses for those preparing themselves to teach Family Relations); 3. Courses in Family Relations in Public Schools (a. Encourage high schools to include in their curricula courses on preparation for marriage and the family; b. Provide consultation for the development of appropriate education programs on family life on the grammar school level); 4. Coordinate all efforts in family relationships within each state and strengthen state programs; 5. Encourage state and local family councils to become aware of the many federally-supported health, education and welfare programs and what they provide, and to assume some responsibility for introducing into them projects and programs about family relationships and facets of education for family living; 6. Supply family understanding, support and guidance so it can more adequately accept and absorb those who have been mentally ill and have now returned home. President of the Council is JOSEPH ROWLAND, P. O. Box 4964, University, Alabama 35486.

The theme of the September conference of the MASSACHUSETTS COUNCIL was "Changes and Stresses in American Marriages." Awards were given to MARY CALDERONE, M.D., S.I.E.C.U.S.; ELIZABETH FORCE, A.S.H.A.; and NORMAN PAUL, M.D., Boston. In their June Newsletter they unfolded an 8-point program to mobilize the resources and leaders of that state to: 1. Call upon the Governor to convene a State House Conference on Marriage and the Family in order to enlist public support for action in the fields of education, counseling, research, and legislation; 2. Support the Advisory Council on Home and Family appointed by the Governor last December, so that it will have funds to conduct studies and research into: laws relating to marriage; causes of family disintegration; programs to promote stable families; and the impact of family breakdown on welfare costs, juvenile delinquency, and crime; 3. Study of legislation affecting the family, especially in the areas of divorce, conciliation services, adopted children, and public welfare; 4. Workshops and seminars for the training of marriage and family counselors and the preparation of teachers in sex and family life education, as well as a program of state accreditation and professional standards; 5. Participation in voluntary and government programs with stable families as the target, and the organization of family life councils on a regional and inter-disciplinary basis; 6. Education and counseling for unwed mothers and fathers, and courses to help those still in high school to finish their secondary education; 7. Sex education from Kindergarten through 12th grade in all schools; 8. Parent and adult education, beginning with preparation for marriage and childbirth, and focusing particularly in the area of sex. BOARDMAN KATHAN, 14 Beacon Street, Boston, Massachusetts 02108, is president.

The MINNESOTA COUNCIL held its annual meeting November 3-4, at the University. The theme was "You Cannot Not Communicate," NCFR members on the program included DR. AND MRS. JAMES MOORE, Purdue University, and HARLAN NOREM, Augustana Academy, South Dakota. RON PITZER, Extension Specialist in Family Life, Agricultural Extension Service, University of Minnesota, St. Paul, Minnesota 55101, was elected president.
