FROM THE NCFR PRESIDENT, ELIZABETH S. FORCE

1969 and 1970 will be historic years for the National Council on Family Relations. Caught in the maelstrom of social change, NCFR, like most other organizations, institutions and agencies, seeks to reassess its goals, philosophy, program services and potential. Such reassessment creates discomfort, confusion, perhaps pain; but also excitement, hope and growth.

One important step toward this reassessment was the appointment in 1967 of an ad hoc committee on long range planning. The committee's report, submitted to the Board of Directors on October 18, 1968, challenged the Board to come to terms with the times and the needs of the membership. In brief, the report proposed modifications in the administrative structure of NCFR; considered relationships with affiliated groups, suggesting ways of clarifying the ties that bind; explored priorities of services, and examined their relevance to both the membership and the family field. It urged that action be taken speedily.

The Board accepted the report of the ad hoc committee and referred it to a task force for study and for recommendations. The Task Force members are Jessie Bernard, Eleanore Luckey, Clark Blackburn, William Genne, Richard Hey, and Carlfred Broderick as chairman. He will serve as a bridge between the Task Force and the Long Range Planning Committee. A sense of urgency rightfully exists, but the matters to be considered will be best handled in a climate of calm, seasoned deliberation rather than in an atmosphere of pressure which might encourage hasty decisions. Therefore the Task Force deadline of three months may of necessity be extended.

It is my thought that this general information concerning the present self-study of NCFR might stimulate the members to think along with the Task Force about the issues, to reflect upon the possibilities and alternatives, and to develop creative ideas of their own. While the Task Force is addressing itself to its sensitive and difficult assignment, the rest of us can be doing some homework too.

A bit of perspective may be helpful. In its founding year, 1938, NCFR was an intimate, cohesive group of about 200 persons; in 1968 NCFR is a less cohesive organization of about 5,000 members.

In 1938 we knew who we were; in 1968 we had to ask the help of the computer to find out who we are. The computer will provide clues to our organizational identity but it will not tell us all we need to know.

To find out not only who we are but also who we want to be, questions like these are continually raised: What was NCFR originally set up to be and to do? What are we now set up to be and to do? Where are we most successful? Where are we least successful? To what does the membership want NCFR to commit itself? To what extent does the membership want to commit itself to NCFR? What kinds of tasks are we called upon to perform? Which of the many important and diverse tasks should be given priority? Do we want to develop our educational functions or do we want to work toward a more action-oriented program? Do the affiliate groups have the same tasks and functions as the national organization or are our jobs and services different? How do we help one another?

The even harder questions raised by the report of the ad hoc Long Range Planning Committee will require hard study and will result, no doubt, in some hard answers. Will the membership be willing to pay the price for growth not only through dues commensurate with demands, needs and services, but also in personal energy, renewed dedication and constructive effort?

Our identity as a national organization must be clear and unmistakable. Our energy must be harnessed to significant causes clearly articulated and not to random activities. In these times we must make wise and courageous choices. "To be safe everywhere is to be safe nowhere," warned Winston Churchill.

How can NCFR best serve the family and the family field? What is our unique contribution? How can we bring influence to bear on matters of social concern that affect persons and families? Let it never be said of us that our influence exceeds our wisdom, but rather that our collective wisdom born of scholarship, varied experiences and genuine concern is significant because it is valid, because it is sound, and because it is selfless.

### NCFR-SPONSORED SEMINARS ON FAMILY LIFE EDUCATION

The following proposal was passed at the 1968 NCFR Board Meeting: (1) That plans be made for the first NCFR training seminars in family life education to be in the summer of 1970, with seminars in all regions; (2) That the seminars run for two weeks of intensive all-day sessions; (3) That the seminars be sponsored with the universities which offer facilities as residence halls, food services, libraries, educational media equipment, classrooms, and laboratories, etc.; (4) That the universities be accredited and able to grant credit in areas such as child development, home and family life, sociology, etc.; (5) That efforts be made to get federal or foundation help in financing the seminars; (6) That the seminars be run by NCFR-approved personnel; (7) That preparations be made in planning meetings during 1969, which would allow selected personnel to develop curriculum and pedagogical plans for the seminars. It is recommended that the meetings consist of three, two-day retreats; (8) That the NCFR, if necessary, finance the 1969 planning meetings; (9) That those participating in the meetings attend one or more of the seminars; (10) That the seminars be run by two specialists who have been to the 1969 planning meetings.

### WINNERS OF 1968 NCFR AWARDS

Two awards for outstanding service were presented at the 1968 Annual Meeting in New Orleans. Recipient of the Osborne Teaching Award was JAMES T. WALTERS, Head of the Department of Home and Family Life, Florida State University. For outstanding research in the family life field, ROBERT WINCH received the Burgess Award. Dr. Winch is with the Department of Sociology, Northwestern University. Both Dr. Walters and Dr. Winch were awarded a certificate and \$500 in cash.
