At the Annual Business Meeting of the NCFR in Washington, D. C. in October, it was voted to submit to the membership for a referendum vote a statement setting forth a NCFR position regarding family life and sex education, prepared by the newly formed Family Action Committee. The statement follows. Please use the enclosed envelope to return your ballot indicating your acceptance or rejection.

POSITION PAPER ON FAMILY LIFE EDUCATION

I. The National Council on Family Relations is an organization composed of individuals from various professional fields. It has a long-standing and continuing commitment to educational programs which aid individuals in developing a constructive and fulfilling personal and family life.

II. Family life education is one such program to guide individuals and families in improving their interpersonal relationships and furthering their maximum development. It seeks to improve the quality of life throughout the entire range of human development. This includes physical and emotional growth, individual sexual development, dating and courtship, marriage and parenthood, while continually emphasizing the importance of personal integrity and family responsibility.

III. The National Council believes that there is presently an urgent need for schools, churches, and other social institutions to develop quality family life programs for children, youth, and their parents. Such programs require the development of family life materials based on scholarly research. The leaders should be prepared to utilize such materials and to relate meaningfully to others. These programs should also be sensitive to the various moral viewpoints involved in this field, but should not impose any particular moral position. The content and type of presentation should be adjusted to the age and developmental level of the individuals involved.

IV. One important aspect of family life education is sex education. Sex education is much more than a focus on the biological and physical aspects of sex or the physiological processes of sexual development. It is this narrow and inadequate definition which education in family life seeks to change. Adequate sex education provides

individuals with current and reliable information about their own physical and emotional development so that they may better understand themselves and be more capable of relating to others as total human beings in honest and responsible ways.

V. The National Council on Family Relations recommends that comprehensive and sequential family life programs, which include sex education should be a planned portion of the regular curriculum from pre-school through college. It further recommends that these programs should actively involve parents and that adult family life programs should also be developed.

NEWLY FORMED FAMILY ACTION COMMITTEE AND SECTION

The Family Action Group, better known as "FAG-69," was officially founded on Thursday, October 23, 1969, at the Annual Meeting of the National Council on Family Relations. In its brief 48 hour existence, the Group was recognized with enthusiastic support by the Executive Committee and was officially given Committee and Section status in NCFR.

The Group is vitally concerned with focusing on relevant and pressing social issues in our society and with facilitating the role of NCFR in developing and implementing a policy of responsible social action. The Group proposes that there be greater integration and utilization of family research and family theory aimed at understanding and amelioration of contemporary social problems. It also proposes that NCFR publicly make position statements on these issues. In such troubled times, we as family professionals have an obligation to speak out and to take responsible action on matters concerning family life. Although the Group was initially composed primarily of students and young professionals, it is vitally concerned with the active participation of all NCFR members.

At its first official meeting, the Group proposed that it be recognized as an official group in order to better implement its philosophy

and that representatives from this group be appointed to serve on the various NCFR committees. David H. Olson (NIMH) was elected as President to represent the Group. He presented these proposals to the Executive Committee of NCFR which unanimously approved that there be established a Family Action Committee and a Family Action Section of NCFR. The Committee will handle organizational matters and will set objectives and priorities for Family Action. The Section will primarily be responsible for planning the program of the Family Action Section for the NCFR Annual Meeting. Since the Group was given Committee and Section status, the Group "FAG-69," per se, passed out of existence in a cloud of accomplishments, all of which should advance the philosophy of family action.

The following is a list of the specific objectives which the Family Action Committee (FAC) has initiated in this, the first year of its existence:

Completed (1) It was proposed by FAC to have student-young professional representation on all the Committees of NCFR. This was presented to the Executive Committee and was unanimously approved. The following students and young professionals were appointed to serve on those Committees:

Completed (2) It was proposed by FAC that a position paper be written regarding the effect of the Viet Nam War on family life in Southeast Asia and America. The initial paper was written by Gordon Shipman, Wisconsin State University, Stevens Point, revised in a form which was unanimously approved by the Executive Committee and passed by the members at large during the annual business meeting of NCFR. The following statement was sent to President Nixon and released to the press:

Position Statement on Family Life and the Viet Nam War

Whereas the National Council on Family Relations is an organization representing numerous disci-

plines, all of which focus their attention on the improvement of family life; and

Whereas the Viet Nam War with its intensification of militarism is concomitant with personal, social and family disorganization; and

Whereas the continuance of the war depletes our human and material resources which are so badly needed to develop and strengthen social and economic programs necessary for wholesome family living; and

Whereas we are gratified that the President has already committed himself to a partial withdrawal of troops from Viet Nam and hopefully plans an immediate termination of the war;

We as members of the National Council on Family Relations now recommend that the President of the United States, in cooperation with the Congress, appoint two Presidential Commissions:

One to study the effects of the war on family life in Southeast Asia and to make recommendations on how our nation may best contribute to the rehabilitation of family life therein; and

The second to study the effects of the war economy and military losses on families in America, especially those of minority groups, and to make recommendations regarding the improvement of American family life.

It is further recommended that these commissions be recruited from recognized specialists in the family field.

Completed (3) The FAC has written a position paper on family life and sex education for the NCFR organization. Such a proposal has been attempted by several groups and individuals in the past but has failed to meet the approval of the Executive Committee. The present proposal from FAC is contained in this Newsletter and is presented to the membership for referendum. *accepted*

Current (4) Proposals initially written by the Women's Liberation Movement on child care, abortion laws and other related topics were presented and tabled at the NCFR business meeting. These proposals will be worked on by the FAC and also will be sent to the members for referendum.

Current (5) The Family Action Section will organize the program for this Section at the Annual Meeting of NCFR in Chicago next year. Since the theme of the conference will be "Violence and the Family," papers in the Family Action Section will be devoted to understanding the development and acceptance of violence in families in America and to developing constructive plans for changing our violent society.

Those interested in presenting a paper during the Family Action Section meetings at the conference should send a 200 word abstract by February 15th to Paul Weikert, College of Human Development, Pennsylvania State University, University Park, PA 16802.

Current (6) A special project which the Family Action Committee will also work on this year is to increase the number of student and regular members. Recruitment will draw heavily upon the participation of student members, in addition to the usual techniques used in membership drives.

Current (7) At the present time, several states do not have state NCFR chapters. FAC will attempt to help establish chapters in these areas and will work toward having student representation in all of these chapters.

Future (8) Review of undergraduate and graduate programs in the areas of family relationships and marriage counseling will be undertaken in the near future.

Future (9) Development and implementation of liaison between the NCFR and the government with special attention to funding for family and community action programs, for family training programs and for research programs on families is another project of FAC.

All members of NCFR are encouraged to join the Family Action Section, even if they also wish to belong to other NCFR Sections. Proposals for implementing the Family Action philosophy are earnestly invited and should be sent to the Chairman of the Family Action Committee, Dr. David H. LETTERS NEEDED

On October 16, 1969, a bill (HR 14379) to prohibit the use of Federal funds for sex education in elementary and secondary schools was introduced in the House of Representatives and referred to the Committee on Education and Labor. NCFR members may wish to write the Chairman of this Committee, Carl D. Perkins; their congressmen; with a copy to the Federal Commissioner of Education.

"Check-up" for Emotional Health, a new concept in prevention, is designed to promote and maintain healthy emotional functioning in the general population. Just as every adult benefits from a periodic medical check-up and an infant's health is fostered by well-baby pediatric service, an evaluation of adult emotional functioning contributes to early detection, requiring minimum follow-up. An evaluation is particularly indicated at significant life stages, such as entrance to college, prior to marriage, parenthood, middle-age, etc. A consultation consists of an exploration of self-esteem, life style, functioning in the important areas of life. Recommendations and referrals are made as indicated.

"Check-up" for Emotional Health is a private program offering its service to industry for its employees, to religious and social organizations for their members, and to individuals. The emotional health consultants are qualified psychotherapists who specialize in diagnostic evaluations of "normal" people. The consultants operate from their own offices, or spend time at an organization. This service originated in New York, but will branch out nationally and internationally.
