# EXCITING PLANS FOR ANNUAL CONFERENCE

The 1971 Annual Conference, Estes Park, August 25-28, is being given form and content by the five Section chairmen and others who contribute significantly to what goes on at such a conference. With the change of format from large listen sessions to small get-in-there-and-pitch groups, each of the five Sections is planning about thirty different sessions. This means that when you register, you will be able to select one from twenty-five or more offerings for each of the program periods! With as tempting a program as is in the offing, we'll all have to fight off seizures of choice neuroses and get registration requests in early in order to get our first-choice sessions. Conference registration forms, including those for Section Meetings, will be sent you in May. The housing reservation form included with this Newsletter is to be returned directly to Colorado, not to the NCFR office.

The Annual Meeting will have its official opening with dinner and a Presidential Session, Wednesday, August 25 at 6:00 p.m. However, preconference meetings will begin at noon and will provide for special groups who want to get together ahead of the meeting. A luncheon meeting at noon, Saturday, August 28 will close the conference and leave you with a short weekend on hand in the Rockies.

Each group will be developed either around a topic or a person or group of people; for example, the Research Section under the chairmanship of Richard Udry will offer the following topics: Dyad Formation Processes, Variant Marriage Forms, Methodological Problems in Sex Research, The Family as a System, Methodological Problems in Research on Masculinity-Femininity, Sexism in Family Research, Generation Gaps, The Agony and the Ecstacy of Longitudinal Research on Marriage, Childless Marriages, The Black Family, Communal Family Groups, Premarital Sexual Behavior, Research Problems in Family Planning, Theories of Mate Selection, The Impact of Family Research on Social Policy, Ethnic Group Family Structure. Some of the people who will be involved with these sessions will be: Murstein, Whitehurst, Bell, Broderick, Christensen, Bernard, Thomas, Olson, and Veevers.

The Education Section chaired by Barbara Chandler will focus on Community Programs as Resources for Family Education and Family Development. The program is being correlated with two major sessions for representatives of NCFR Affiliated Councils. A packet of materials will be sent to registrants so that we can all do our homework. Greene; "Value Stance of High School Teachers Regarding the Family," Richard K. Kerckhoff; "Day Care Programs," Barbara Sawyer; "Community Mental Health Center," Darrell Spoon; "Parental Guidance in the Character Education of Their Children," Herman Williams; "Parent Participation: A Demonstration Project Focusing on New Dimensions for Community Service," Jane Berry; "Extension Services," June Bricker. There will also be sessions built around films such as: "The Eye of the Storm," "The World of Peri Thomas," and "Rocka-Bye Baby."

Michael Sporakowski, Chairman of the Family Action Section, is planning sessions on the following topics: Alternate Life Styles, Developing a Private Family Life Agency, Sexism in Children's Books, Courses on Women, Legal Remedies for Discrimination in Higher Education, Hyponatology, Nonviolence and the Family, Abortion Papers, Pre-Marital Counseling for Teenagers, Family Camping, Variations in the Family: Where It's Headed?, Women's Liberation, a Community Sex Education Project. Angrist -- Counseling with College Women on Career Aspirations; Gerhard Neubeck--Extra-Marital Relations and Counseling; Bert Glassberg--The Counselor and Confidentiality; John Greene and panel--Some Unique Psycho-social Factors in Marital Interaction Patterns of Black Couples as Seen in a Clinical Setting; William Nichols--Therapeutic Intervention in Marital Discord; John Burton--Group Experience: Theory and Practice in Counseling; Frederick Humphrey --Critical Moments in Marriage Counseling.

Theodore Johannis, Chairman of the Special Emphases Section, has not yet chosen all of his topics or discussion leaders. However, at this time he can tell us that his sessions will be devoted to the important topic of the Family and Leisure.

Most of the Sections will be offering at least one workshop opportunity. Those already on the drawing boards are: a research workshop on family theory, one on population control, one on writing for professional publications and one on the development and use of family study centers.

Special features will also include a series of meetings under the leadership of NCFR officers and Executive Committee members on Directions and Development of NCFR.

Conversation hours are being arranged so that younger members who would like to do so can meet and talk with some of the people they've read about but haven't met.

Encounter groups will be available for a limited number of participants; film sessions are being scheduled by Deryck Calderwood; some special demonstrations are being planned; and a "drop out" room and book exhibit is being set up for people who want to drop out of their scheduled group and have a cup of coffee with a fellow delinquent or catch up on their reading. Gladys Phelan is chairman of the 1971 Book Exhibit. All this and recreation, too. Available both on schedule and off schedule will be swimming, tennis, horseback riding, hiking, games, handicrafts and the magnificent Rockies. Bring your musical instruments!

We are also on the trail of a couple of most exciting plenary speakers who will be announced later, and we're planning for entertainment that will be more than a substitute for city night life.

Special groups may arrange meetings by getting in touch with program chairman, Eleanore Luckey, or Ruth Jewson. One such group that is already under way with plans is the Affiliated Councils. They will meet Wednesday afternoon at 2:00 p.m. on the topic of "PPB for Affiliated Councils." A later session will be on "Citizen Participation in Family Relations Programs."

If groups wish to get together for meals, this too can be arranged if you let us know in time. How about a Merrill-Palmer breakfast, or a Minnesota lunch, or a Columbia T.C. hour? Those who are interested in follow-up plans of the White House Conference on Children and Youth, or the Aging can schedule yourselves a slot of time. The program is designed for this kind of flexibility and this kind of communication. Help us take advantage of it.

Finally, there are some things you should know about Estes Park in order to do your best planning. Remember that mornings and evenings are cool. Afternoons are warmer. The temperature will probably vary from 49 to 80 degrees. Plan to live mainly in slacks, pants suits, warm sweaters and jackets. Bring a rain coat. Groups will often meet outdoors, where vigorous discussion will go on in the midst of alluring scenery.

#### Ontario, Canada

Sheridan College, Oakville (near Toronto), Ontario, Canada, will host a NCFR-approved workshop July 5-16, entitled "New Approaches in Family Life Education." Co-directors will be Joel Moss, Chairman, Child Development, Family Relations, Brigham Young University, and Don Wilson, Family Life Consultant at Sheridan College. Among the guest speakers will be Eleanore Luckey, Chairman, Child Development and Family Relations, University of Connecticut; Richard Kerckhoff, Chairman, Child Development and Family Relations, Purdue University; Howard Irving, University of Toronto. Topics will include significant issues in family life education, the teacher and values, building relationships with students, resources in family life education, and the teacher as a researcher. The workshop will emphasize new and creative ideas in teaching family life education and applying concepts to influence behavior. In addition, she is consultant for the Institute for Educational Development, and has just completed a 4-session orientation program, with the teachers during the school day and with the parents in the evening, in a Washington, D.C. school which will soon launch a sex education program. The orientation was geared to help the school administration, the teachers, and the parents be aware of the need for an ongoing program in human sexuality for the teachers and the parents, so that the program for the children may be more effective.

Armin Grams has joined the faculty of the University of Vermont as Professor of Human Development. His major responsibility is to build an interdisciplinary teaching and research program at both the undergraduate and graduate levels.

The Merrill-Palmer Institute held a Family and Society Conference, February 25-26, "Alternatives for New Life," life styles and family forms of various counter-cultures. Resource people included Robert Blood, Aaron Auerbach, Larry and Joan Constantine, and Ron Scott.
