PRESIDENT'S COLUMN

FROM ELEANORE LUCKEY

A sizable majority of NCFR members have indicated within the last two years that they are eager to see our organization be more meaningfully involved in the social scene. One way of doing this is to become more visible in the Halls of Legislation at both national and state levels. Most members do not intend or expect NCFR to become a pressure group and are aware that our tax-free status could be endangered by any move in that direction; but to let law-makers know where the majority--and incidentally, also where the minority--of our members stand on issues that relate to the family has seemed desirable enough that the Board of Directors at their last meeting instituted a method by which this could be done.

A letter was sent to President Nixon, to Congressmen, to Governors, and to many other public officials regarding NCFR's majority position on abortion and population control. The Board urged Affiliated Councils to take similar steps at state levels; but as far as I know, no Affiliate took such action--probably because, like NCFR until its last Board meeting, there was no official way to do it.

NCFR now has a process which we believe is sensitive to social and legislative issues that involve the family and which can be set into operation by any interested NCFR member. (See May NEWSLETTER.) It can be made to work, however, only if a member or group of members trigger the action. We've made ourselves heard on two issues; on the Daycare Bill--which seems to me to be pretty important to family welfare--we didn't peep. We've been heard by the federal law makers--we're still silent at state and local levels.

The response that we've had from our first action has been encouraging, but not overwhelming. Two White House Staff Assistants to President Nixon replied, thanking us for our views--I'm not sure that the double response meant they were especially appreciative or that there is duplication in high places! Of the 50 governors to whom we sent letters, we had 11 responses--some agreeing, some disagreeing, and some very non-committal. Eighteen Senators--including McGovern, Muskie, Bayh, Ribicoff--and 11 Representatives replied. Most of them wrote letters which sounded as if they had read and considered our letter. We had 17 letters from other heads of agencies and dignitaries in high places.

There were also letters from our own membership. Some of our members lauded the Board action and said it was high time! A few deplored the action and felt the step to express a position on controversial issues was generally detrimental. It is clear that if NCFR is to move in the direction of becoming a socially involved organization in any other capacity than that of education, we will not be able to please all the people all of the time. It is also clear that

we have a lot to learn and a long way to go before we are truly an effective social agent, but we have taken the first steps, and there are at least 59 government officials who let us know that they were appreciative of our efforts.

We have instituted a process by which we can be heard; it will work, however, only when NCFR members are concerned enough to initiate the action.

PROJECT FIND

A major outreach campaign, Project FIND, was launched August 3. This is a massive short term program designed to locate all the lonely, needy elderly people in the United States who have become isolated from the mainstream of American life, to make sure that they understand and are receiving maximum help from the resources available to them. The American Red Cross is in charge of the project, and NCFR's membership is asked to participate in the campaign. How can we do this?

NCFR individual members and NCFR Affiliated Councils are urged to get in touch with local Red Cross directors and offer their help. The aim is to establish a coordinated network of volunteer outreach workers who will find and assist eligible older persons in signing up for benefits at local certifying offices. We hope that many NCFR members can join in this important drive.
