# TFLEGRAM TO SENATOR MONDALE

Following the Annual Meeting in Toronto in October, the following telegram, signed by all members of the Executive Committee, was sent to Senator Walter Mondale (D-Minnesota).

> "We applaud and support your efforts in recognizing and bringing to the attention of Congress and the American public the impact on families of government policies, both proposed and enacted. There has been no family advocate, and issues regarding the Family have been neglected and overlooked. We offer our assistance and expertise in making the family a national concern."

# RESEARCH AND THEORY

Several issues were decided at the first planning meeting, chaired by outgoing chairperson, Joan Aldous.

The 30 persons present voted that the dues for the first year be \$3.00 for regular members and \$1.50 for student members. The persons present served as the nominating committee for the positions of Secretary/ Treasurer and Vice Chairperson. The persons nominated will be contacted and the election will take place as soon as a roster of members is provided by NCFR. The term will be for 2 years and will end after the 1975 NCFR Annual Meeting.

In order to make a smoother transition between terms, it was proposed that the chairperson-elect be chosen one year in advance and serve as a non-voting member of the group. The current chairperson is David Olson, Family Social Science, McNeal Hall, University of Minnesota, St. Paul, Minnesota 55101, who will serve until

the end of the 1975 NCFR Annual Meeting. It was left open whether the chairperson would organize the next Annual Meeting or appoint a Program Chairperson.

The major responsibility of the officers of the Section will be to prepare the bylaws for the Section and to begin initiating projects of interest to the members. Two of the projects already planned for next year's annual meeting are the continuation of the successful Pre-Conference Workshop on Theory, which was organized the last two years by Wesley Burr, and will be handled this year by Darwin Thomas, and a Demonstration of Interaction Techniques, which will be organized by David Reiss.

# FAMILY ACTION

The organizational meeting was chaired by incoming chairperson, Sharon Price-Bonham, Department of Child and Family Development, University of Georgia, Athens, Georgia 30601.

It was decided by those people present that Sharon Price-Bonham would appoint an executive committee to help her until, at least, the time the Section has officers elected. The primary purpose of this committee will be to aid her in developing specific purposes and goals of the Family Action Section. She is in the process of contacting people to see if they will serve on this committee.

A nominating committee, consisting of James Lieberman, Mary Heltsley, and Sharon Price-Bonham, was formed to nominate a slate of officers for the positions of Vice-Chairperson and Secretary-Treasurer for the Family Action Section.
