POST-CONFERENCE WORKSHOP ON HUMAN SEXUALITY

A Workshop on Human Sexuality will be led by *Harold and Louise Minor, Southeastern Family Forum, Richmond, Virginia,* on October 26 and 27. The Saturday sessions will run from 1:00 p.m. through 10:00 p.m. and the Sunday session from 9:00 a.m. through 4:00 p.m.  
Goals of the workshop include helping participants (1) identify their personal attitudes and feelings and work with them in a supportive, accepting atmosphere; (2) gain increased acquaintance and comfort with a broad range of sexual behaviors; (3) explore relationships between intimacy, love, and sex; (4) achieve greater ease in communication about sexuality; (5) discover insights related to sexual function and dysfunction; (6) experience and understand the importance of group interaction in sex education; and (7) experience and understand the use of explicit materials in professional leader development in the field of human sexuality.  
The workshop agenda will be built from the concerns and dynamic interaction of the participants. Group exercises, non-verbal experiences, audio-visuals, group discussion, and reflection on the process and philosophy will be part of the design. The workshop is built on the SAR model of the National Sex Forum and the program in Human Sexuality of the University of Minnesota Medical School. Attendance is expected at all sessions.  
Limited to 30 participants accepted in order of application. Fee of \$28 should accompany application. *Harold Minor* was Family Relations Consultant on the National Staff of the Presbyterian Church for several years, Chairman of a nationwide Task Force on Alternative Lifestyles, Chairman of an Ecumenical Task Force on Family Life and Human Sexuality, and served as associate professor of pastoral care at New Brunswick Theological Seminary. Now a free-lance consultant and trainer in family life and sexuality education, he has been conducting workshops in sexuality for Emory University Medical School's Regional Training Center in Atlanta, for the University of Tennessee School of Social Work, and other colleges and agencies.

NATIONAL CONFERENCE ON MARRIAGE ENRICHMENT. First of its kind, this conference will immediately follow the NCFR-AAMFC joint meeting in St. Louis, at the same hotel (the Jefferson). It will begin Saturday, October 26, at 4:00 p.m., and conclude Monday, October 28, at 12:30 p.m.

Ten section meetings will cover such areas as models for couple groups; couple communication; preventive marriage counseling; marriage potential and family strength; love and anger in marriage; marital commitment and personal freedom; sex roles in the enriched marriage.  
Marriage enrichment represents new ventures in new directions--a swing from remedial to preventive approaches, the exploration of marital potential, couples interacting for mutual growth, citizen organizations working with family life professionals and many others.
