THE 1975 ANNUAL MEETING

With the 1974 NCFR-AAMFC Conference successfully over, planning has begun for 1975. Save the dates of August 20-23, and plan to attend the Annual Meeting in Salt Lake City. It's a beautiful place for a family vacation, too, with the mountains just minutes away from the city.

Kate Garner, *Family Life Council of Greater Greensboro, 1301 North Elm Street, Greensboro, North Carolina 27401*, general program chairperson, states that the theme will be "Generations on Generations." Emphasis will be put on the middle years, but with interaction with other age groups of course considered. An excellent speaker, John Silber, *President of Boston University*, has been procured for the August 23rd plenary session. Many members will remember the stimulating address on the "Pollution of Time" he gave at a recent Southeastern Council meeting.

TASK FORCE ON AGING

The new Task Force on Aging "came out" in St. Louis, presenting a special session on intimacy vs. loneliness in the later years, and taking responsibility for two luncheon Round Tables.

The special session attracted--and deeply moved--an audience of approximately 700. This program was recorded, and the cassette tape may be purchased from NCFR headquarters. The two Round Tables were overcrowded, and the Task Force doubled in size, to 40 members.

Clearly, NCFR members share the growing national concern for the well-being of older Americans, and welcome the Task Force as an official expression of this concern. The Task Force began to work, during the conference, on such basic, immediate problems of its own as role definition, clarification of long-and short-term objectives, projects and priorities for its program of work, and the shaping of its organization.

The following decisions reached during these discussions will be used as provisional guidelines:

1) The focus will be on aging and the family, the special area of family

expertise. 2) The role of the Task Force will be essentially a supportive one. 3) All Task Force members will keep as closely in touch as possible with what is now going on in the field of aging.

The most important "business at hand" is the program of work for the coming year. This means deciding on one or two major activities, becoming involved in plans for Salt Lake City, and forming the committees that will take over specific responsibilities. A list of possible projects was developed in St. Louis and is being circulated to Task Force members, who will vote on priorities. Task Force members have volunteered to serve on committees in which they are particularly interested.

TASK FORCE ON WOMEN'S RIGHTS AND RESPONSIBILITIES

The Task Force on Women's Rights and Responsibilities made good use of their Suite at the recent Annual Meeting. On October 23 a presentation on "The Assertive Woman: Strategies for Teachers and Counselors" filled all available space despite lack of prior publicity. On October 24 there was a good turnout for the brainstorming session on next year's program; and on October 25 a meeting on "The Older Woman," held jointly with the Task Force on Aging, had a small but interested attendance. On October 24 a slide presentation on "Changing Roles of Women in Iran" was favorably received.

The Task Force on Women's Rights and Responsibilities decided to expand its activities for 1975, proclaimed International Women's Year by the United Nations. It will cooperate in arranging a plenary session at which women from the world of work and trade unions, education, family, and politics will serve as panelists. The Task Force will cooperate with the various Sections in arranging sessions on a variety of topics. A Final Note: Recently the Board of Directors voted to change the dues structure of NCFR as a result of the overwhelming increase in costs of everything during the last five years. Beginning soon student dues will be increased from \$10 to \$15, which is half of the regular membership dues of \$30. In addition, only students earning \$6,000 a year or less will be eligible for student status.
