The complete 1982 NCFR Annual Meeting Program is being sent you this year, so that you may have time to make decisions ahead of time concerning the myriad opportunities it offers. Please bring it with you to the conference.

Costs for the Annual Meeting

An income tax deduction for educational expenses—costs for travel, meals, lodging, and registration fees—is permitted by the U. S. Treasury regulations, when the purpose of the educational experience is to maintain or improve one's employment. Dues to the NCFR are also deductible when the journals and conferences are needed for professional purposes. The NCFR is recognized by the U. S. Internal Revenue Service as a tax-exempt, non-profit educational or-

ganization.

As you have doubtless noted, NCFR Annual Meeting registration fees are low compared to those of many organizations. In addition, our hotel costs in Washington are quite competitive. The local arrangements committee is preparing a list of restaurants which will include inexpensive eating places. There is much to see in Washington, and a high proportion of it is free.

Did you know that conference hotels make meeting rooms available based on the number of registrants staying in the hotel? The NCFR requires far more meeting rooms than do most conferences. Therefore we would appreciate your planning to stay at the Shoreham. In addition, we urge you to make your plane reservations early. See the final page of the program for airline information. We are told that the days of fare wars among the airlines are ending. As a result we believe that you may find the substantially discounted air fares offered by Cambridge Lord Corporation through its National Airline Reservation System increasingly important.

Meet with Key Federal Officials During the Annual Meeting

Having the NCFR annual meeting in Washington, D.C. presents an opportunity for you to meet with key federal officials. The theme of the meeting, "Families and Government," underscores the relevance of this opportunity. In addition to issues being considered during NCFR presentations, numerous additional topics could be ad-

dressed in such meetings. But why should you take time from your busy schedule to talk with these people?

Reasons abound for meeting them: learning of their priorities, interests and undertakings; informing them of recent research results, needs in your community and/or the impact of federal policies; soliciting their support for an issue; expressing your commitment for a cause; and suggesting areas for needed research.

There is an additional reason for meeting with these people. It was probably best expressed by Lyndon Johnson when he said, "The time to make friends is before you need them." Having an acquaintance at the federal level who is familiar with your work, expertise and interests can be useful.

This meeting need not take a large amount of your time. Most of the people

you may want to meet are located on Capitol Hill or in federal office buildings which surround the mall, both convenient metro subway rides from the Shoreham Hotel. When you have finished, you will be near the Smithsonian museums and several historical sites, enabling you to combine business and pleasure.

Getting an Appointment

If possible, a phone call is probably the most effective and efficient way to determine with whom you want to meet and when. It is best to schedule a meeting 2-4 weeks in advance. Because Congress is scheduled to recess on October 8th for the final election campaign weeks, it is unlikely that you will be able to meet with your senator or representative. However, their staff members are excellent resources and allies and should be cultivated. Explain your purpose for the meeting and make certain you are dealing with someone who is appropriate. Schedule meetings with congressional staff or federal agency personnel who work in areas related to your concerns. Meetings will average 15-60 minutes, depending on the schedule and interests of the personnel involved. Flexibility is essential when arranging a meeting time.

During the Meeting

It is often a good strategy to give the individual something written related to the issue(s) you are discussing. If it is lengthy, prepare a 1-page summary which highlights the major points. Include your name, address and phone number so you can be contacted in the future. During the meeting, make only a few points and make them clearly. You may be able to follow up this meeting by providing additional information, further demonstrating your knowledge, competence and resourcefulness.

Summary

The benefits to be gained from this investment of your time may be substantial in terms of personal recognition and visibility, attention paid to your concerns, and your understanding of current and emerging federal efforts. While less rather than more involvement by the federal government is the goal of the current administration, interest in families and family issues is substantial. The challenge to acquaint key people in Washington with your work, the impact of federal activities on families, and the expertise available through NCFR and its members awaits you. Family Action Section "Special Session"

The Family Action Section is planning a "special session" on the topic, "The Family as a Political Issue." The intent is to have two major speakers representing different perspectives on this issue. They will be Jo Ann Gasper, Deputy Assistant Secretary for Social Services Policy, Health and Human Services, and Ellen Hoffman, Director of Governmental Affairs, Children's Defense Fund. Both speakers have been asked to present their thoughts relative to the family as a political issue, as well as how they view the implications of the different levels of government for this topic.

Pre-Conference Workshop on the Creation of Legislation

This pre-conference workshop is being sponsored by the Family Action Section. It will be held at the Shoreham Hotel in Washington, D.C. on Wednesday, October 13, from 9:00 a.m. to noon. Virginia Sibbison, Executive Director, Welfare Research, Inc., Albany, New York is the organizer.

The focus of this workshop will be the current role that Federal legislation plays in American families and society. Presenters will discuss the process through which

family-related legislation is created; strategies with which advocacy groups can seek to influence the development of legislation; and current in-process legislation potentially affecting families. Speakers and their specific topics are as follows:

Nancy Amidei, Executive Director of the Food Research Center of Washington, D.C. — the role of the advocate in influencing legislation.

Patricia Langley, Washington Representative, Family Service Association of America — lobbying techniques and strategies at the state and local levels, including the role of the voluntary sector.

Rowan Wakefield, Wakefield Washington Associates and the National Center for Family Studies, Catholic University — how the family relations professional can influence legislation. He will also describe how to obtain information on family-related legislative activities and lobbying groups in the Washington area.

1982 NCFR-ACME Family Wellness Conference II: Marriage Enrichment Research Issues

The 1982 Family Wellness Conference II will be held immediately after the NCFR meetings end on Saturday, October 16, in the Diplomat Room, Shoreham Hotel. The Conference will run from 1:30 to 9:00 pm., and will focus on Marriage Enrichment Research Issues. It is designed as a "think tank" on marriage enrichment research for researchers, theorists, trainers and practitioners interested in being on the cutting

edge of this developing field. The conference will open with a keynote address by **Bernard Guernsey, Jr.**, professor of human development and head of the individual and family consultation center, Pennsylvania State University, entitled "Marriage Enrichment Research: What You Always Wanted to Know and Were Afraid to Ask." Dr. Guernsey is a true pioneer in marriage enrichment research; he and his colleagues and students have published numerous research articles and books in the marriage en-

richment area. His keynote address will set the stage for working discussions by the audience centering on critical research issues such as development of systematic and grounded theory, research designs and measurement techniques for assessing change in marital quality and interaction during and after couples participate in a marriage enrichment event, couple group processes and impacts upon couple dialogue, and other dyadic interaction processes and patterns. Audience participants will

have an opportunity to share their own research experience, research instruments, etc. with each other, as well as to develop networks for future collaboration on marriage enrichment research. The registration fee is **\$15 for individuals; \$20 for couples**. NCFR By-Laws Change Proposed

In order to provide the NCFR membership with increased options in the selection of its officers, the following motion was passed at the last NCFR Board meeting:

In addition to the nominees chosen by the nominating committee for elected offices, a member, by petition, can become a candidate on the slate for any particular office in any given election. For the election to the office of president-elect, program vice-president, program vice-president-elect, membership vice-president, publications vice-president, secretary, and treasurer, a petition signed by 60 members would automatically include the petitioner on the ballot. For election of Section officers, a petition signed by 25 members of the Section would automatically include the petitioner on the ballot. The petitioner will have 30 days after the nominating committee's slate is posted to complete the petition action. The petitioners will supply signatures, names, and addresses for office verification.

The motion now goes to NCFR members to be voted upon. If accepted, the new procedure will be put into effect in the 1983 elections. The 1983 nominating committee, elected in 1982, will announce its slate in the December 1982 Newsletter. Members will be able to petition for additions to it, which will be included in the ballot appearing in the March 1983 Newsletter.

Your ballot is enclosed with this Newsletter. Please return it by **November 1**. The enclosed addressed envelope may be used

to return both the ballot and your registration forms for the NCFR Annual Meeting.

in memoriam

Judson T. Landis

Judson T. Landis, president of the NCFR in 1956 and long-time member, died June 6, 1982 in Oakland, California. Dr. Landis is remembered warmly in the NCFR office, for a few years ago he presented us with new office equipment.

Landis was professor emeritus of family sociology at the University of California in Berkeley. His courses covering courtship, mate selection and husband-wife adjustments in marriage filled the lecture halls on

campus during the 1950s and 1960s.

He authored four books on adolescence and marriage. *Building a Successful Marriage* (co-authored by his first wife, **Mary Evaline Green**, who died in 1973) was used as a college textbook and has been published in seven editions.

He is survived by his widow, **Grace**; children **Judson R. Landis** and **Janet Landis Summers**; step-children **Kathryn Burkhart David**, **Alice Watterson Camwell**, and **John Watterson**; brothers **Wesley** and **Paul Lan-**

dis; sister **Esther Roushey**; six grandchildren and two step-grandchildren.

Paul K. Houdek

NCFR member **Paul K. Houdek**, marriage counselor and sex educator, died March 7, 1982 in Kansas City, Missouri. He was an active member of the NCFR for many years. Houdek was particularly known for *Sex News*, a monthly digest of "news, views, events, publications, and resources."

Another exciting development is the 'out Reach' component which is taking parent education in the community via PTAs, housing authority, churches, etc. This is a direct response to requests by such groups and is being designed specifically to meet their needs. At present this program is being funded by a grant from the Sternberger Foundation. It is anticipated that additional support will be coming from the Junior League. A very excited advisory board has begun and they expect to generate a lot of possibilities for the program...The Council President **Claudette Burroughs-White** appointed a much needed long range planning committee which has been very active this year. Many areas of the Council's activities (e.g. by-laws, policies, committee structure) need to be updated especially with the incorporation of G.A.C.Y. Board members have been appointed to work on the recommendations and it is expected that these revisions will have many benefits for the total program...This program year has been an exceptionally busy one, not only for the above reasons. Requests for services, programs, and consultations have been very high. Close to 2,000 more people participated in Council programs or services than last year. It appears that more organizations, especially churches, are interested in doing programs for families. The idea of preventing problems rather than reacting is catching on. to be our coordinator. He talked to the Social Science Club about my coming and arranging such a program. In the course of the discussion they decided that they would develop a whole day on the theme "The Changing American Family." They decided on some topics for workshops during the day and invited people from community agencies to conduct these workshops. There was a dinner, at which I spoke informally about PCFR and also NCFR. In the evening, I gave a presentation.

"The utilization of my coming as the basis for creating a day was something that had never happened before at Penn State. Marty and the others who had helped him plan it were extremely pleased that in the course of the day some 250 people attended some part of the program. Further, in yet another surprise, the Sharon Herald sent a reported to cover the program which resulted in a long article on the conference and on each of the speakers. And, of course, the PCFR was publicized as the sponsor of the conference. They're now talking about having such an Annual Conference.

"It is evident that our efforts to form a Regional Council had a much bigger payoff than we had anticipated; in generating interest and participation by the community and a coming together of professional colleagues."...President Gershenfeld's address is Pepper and Winter Roads, Rydal, PA 19046.

SURVEY ON THE FAMILY PROTECTION ACT

The attached "Concept Summary" for the Family Protection Act (S-1378) outlines selected provisions of this bill, using language provided by Senator Jepsen (R-Iowa) who re-introduced this bill in June 1981. An exploratory survey was conducted at the 1981 NCFR Annual Meeting and the results were reported in the May *Newsletter*. This survey is an abbreviated version of the Family Protection Act, focusing on provisions which elicited a strong opinion from the earlier respondents. It is directed to the **entire** NCFR membership, not just those attending the Annual Meeting, and the results will be provided to Senator Jepsen who has been invited to speak as well as to other organizations interested in this legislation.

The NCFR Public Policy Committee believes that this proposed legislation deserves consideration by NCFR members, because its stated purpose is to strengthen families by removing government interference and returning "the jurisdiction of the family back home where it belongs."

Because the Family Protection Act is a conglomeration of issues, it will not pass as one piece of legislation. Senator Jepsen has and will continue to extract concepts and introduce them as separate bills. Therefore, each concept must be rated individually.

Would you please take the time to rate what **you** think about each provision? Your participation is critical. The Public Policy Committee will collect and analyze this information and report the results to the membership at the Annual Meeting in October.
